If for any reason the replacement is unavailable, a full refund of monies paid shall be the entire obligation under this contract. No other guarantees or compensation is payable under the terms of this contract.

<b>5) PAYMENT:</b> In full consideration tor all services rendered by the Artist at the location, the Client agrees to make the following payment to Philosophy Hair & Beauty Co. a non-refundable £100 deposit is required to hold your					

- a) **Deposit:** Client will pay £100 to Philosophy Hair and Beauty Co. This deposit will be credited toward your balance of the wedding day. This deposit will not be refunded if client cancels for any reason within 8 weeks of the wedding date.
- **b)** *Payment of Balance:* 1 month prior to wedding date payment must be made in full either by Bacs (bank transfer) or in person at Philosophy Hair & Beauty Co. Failure to pay the balance will result in the event date being opened up to other clients.

**6) Trial:** It is strongly recommended you book at least one trial prior to your event, however, booking a trial does not secure Philosophy Hair and Beauty Co services for the 'event'. The trial is paid for at the time of the trial, and an accurate quote will be provided including any accessories, padding, hair extensions etc. All timings will also be confirmed at the time of the trial. The event booking is only secured once the deposit has been paid (as above.)

## 7) MISCELLANEOUS.

a/ It is the Brides responsibility to make known any allergies or sensitivities to hair, makeup and skincare products. Standard skin sensitivity tests will be carried out for any products with common allergens only.
b/ Any additional work on guests carried out on the day will be carried out only when the above agreed bookings have been completed and will be payable in cash at the time of the service.

## 8) CANCELLATION.

Cancellations, for whatever reason will be fully refunded if we are notified 12 wks or more prior to the wedding. 50% will be refunded for 6-12 weeks notice of cancelation. No refund will be given with less than 6 weeks notice and full payment will be required for services cancelled within the last 4 weeks of the wedding date.
